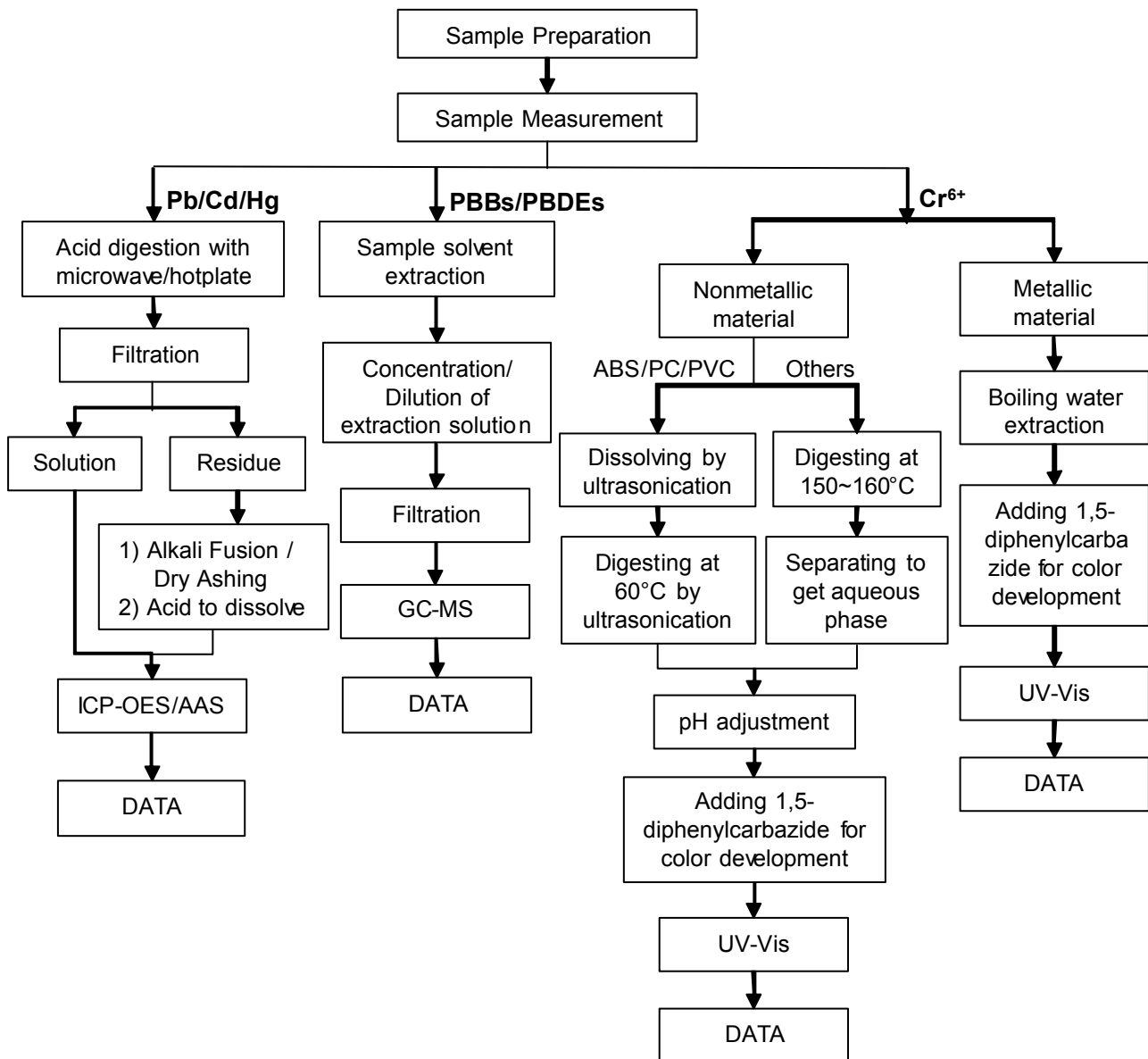

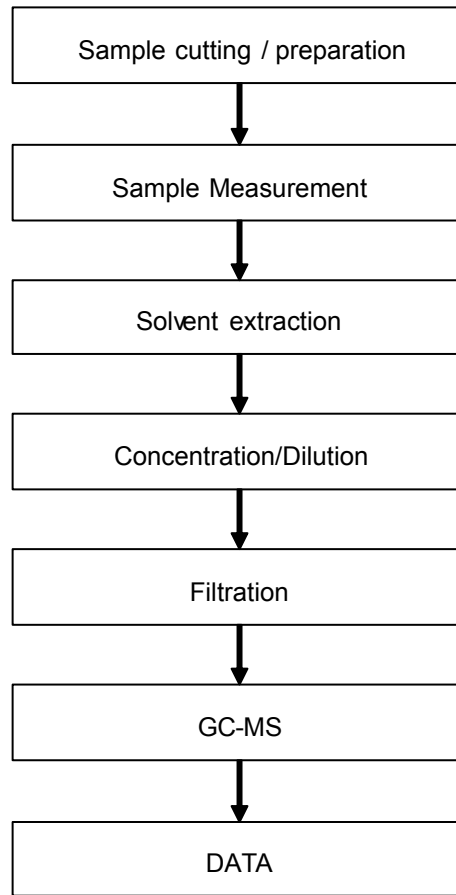

Phthalates Testing Flow Chart

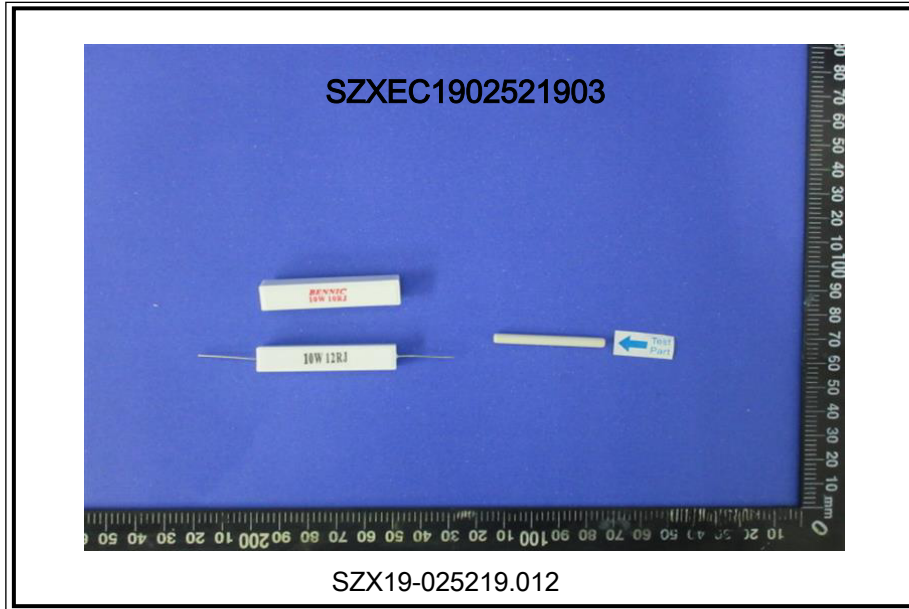
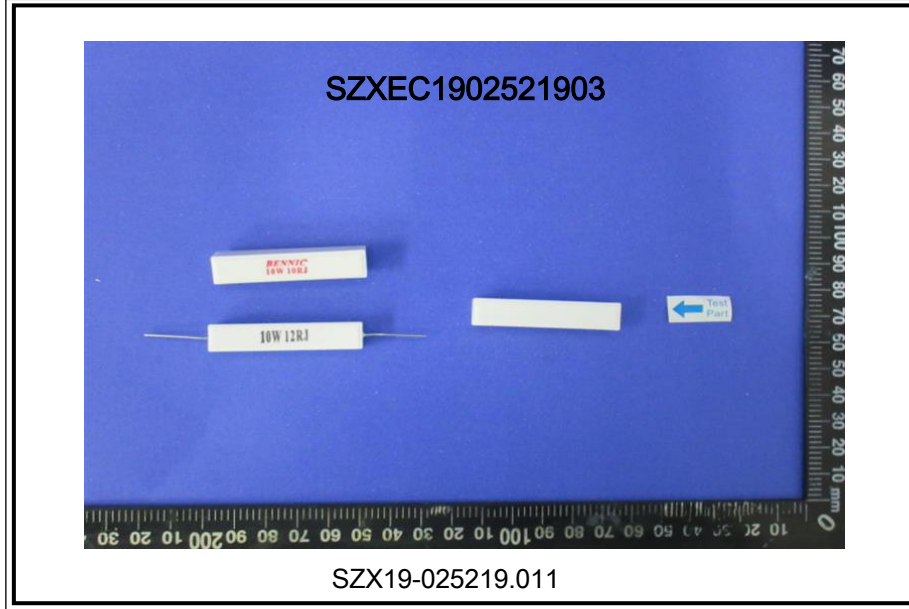
